Water Supply: 3.02% Motor Fuel: 2.93%

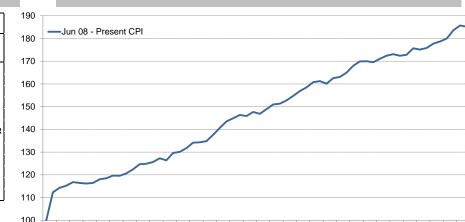
Doctor Clinic Fee: 2.52%

Chicken: 24.50% Tomatoes: 23.60% Fresh Fruits: 15.48%

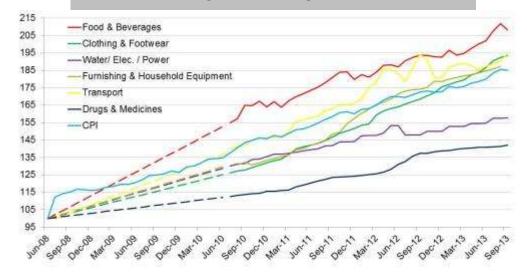
Food & Beverages segment decreased by -0.3% owing to decrease in fruits and vegetables. Owing to increase in fuel prices and load shedding of CNG, Transport costs have risen by 2%. Drugs and Medicine, Medical equipment's and medical tests have shown minimal increases however the Doctor (MBBS) Clinic Fee has significantly risen by 2.52% which is why the health index has increased by 1.18%.



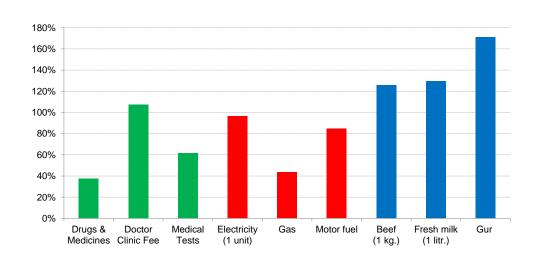
CPI Index - June 2008 - September 2013

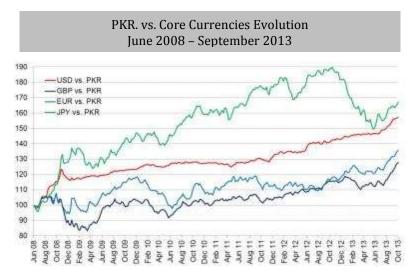
June 2008 - Present Inflation Index

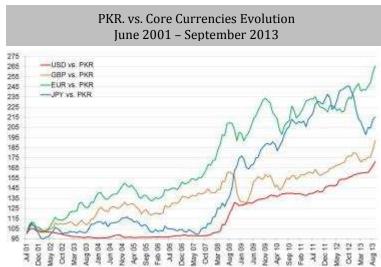

Core Currencies



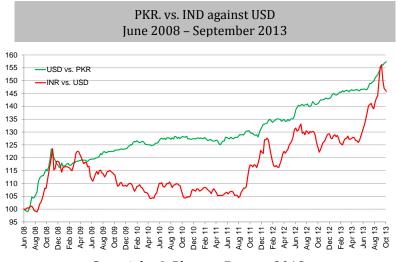

The Pakistani rupee reached a record low against the USD hitting the 110 mark in September. IMF payments and a bleak outlook were the 2 main attributes to this. These levels then cooled down with the USD now hovering a little over 105 mark. Meanwhile the USD has performed poorly versus the major currencies on the fears of a recession risk.

Remittances in the start of this fiscal year show us a 7 percent yoy increase and have helped keep the exchange rate levels somewhat static. PKR is more pressurized as the state bank of Pakistan increases its purchase of dollars, appreciating imports of oil and food depreciating the rupee

The Indian Rupee has managed to scale down from the low levels it had witnessed in August. The last 2 weeks saw the INR gain considerably vs. the USD.



PB News Update

- Several follow up meetings have taken place in September with regards to an inflationary price adjustment
- In August 2013 DRAP published a Draft Medical Device Rules, 2013 to regulate Medical Device Industry of Pakistan (Importers and Local manufactures). While Provincial Health Authorities were asked for their comments industry stake holders and trade associations were unfortunately not taken into consideration.
 - PB took this matter up urgently and formulated a team consisting of regulatory leads: Asma Zuberi (Johnson Johnson) assigned lead, Seema Faraz (B. Braun), Dr. Aslam (Otsuka), Altaf Lodhi (Roche), Seema Khan Anwar Khan Novartis, Aftab Ahmad Khan/Adil Siddiqui (Novo Nordisk) and Muhammad Shahrukh & Khalid (Merck).
 - The PB requested a 1 month timeframe to submit their recommendations.
 - The team worked exceptionally hard, conducting several sessions to review and prepare the assessment of the draft. Principals of the working group were also contacted to review the draft critically.
 - On 27th September 2013 PB submitted an extensive recommendation and assessment covering all aspects of the Draft Medical Device Regulation.
 - The committee continues to follow up with legislators.
 - We at the PB would like to thank the committee for its efforts and in particular would like to acknowledge the efforts of Asma Zuberi.
